

Join Action Global Health Impact: pubblicato il leaflet di progetto

È stato pubblicato il leaflet relativo alla Joint Action Global Health Impact, nell'ambito del Programma EU4Health, che ha come obiettivo il rinforzo della leadership europea sul tema della Global Health e la creazione di un sistema di coordinamento fra Unione europea e Stati membri per dirigere in maniera efficace, efficiente e sostenibile le politiche afferenti al tema

L'Azione comune sulla salute globale, istituita nell'ottobre 2023, è un'iniziativa che si inserisce nel processo di revisione della Strategia dell'Unione Europea per la salute globale, denominata "**Better Health for All in a Changing World**" (Migliore salute per tutti in un mondo in cambiamento), introdotta dalla Commissione europea nel novembre 2022.

Questa strategia mira a **rafforzare la capacità dell'UE di rispondere alle sfide sanitarie globali**, garantendo un approccio coordinato e integrato alla salute pubblica su scala mondiale.

A nome della Presidenza belga, **sono state approvate le conclusioni del Consiglio dell'UE riguardo la strategia per la salute globale**, che evidenziano l'importanza di rafforzare la cooperazione internazionale in campo sanitario e di migliorare l'accesso ai servizi sanitari e ai medicinali essenziali, soprattutto nei contesti più vulnerabili. La strategia si concentra anche su temi come la preparazione alle emergenze sanitarie globali, la promozione della salute e il rafforzamento dei sistemi sanitari, con particolare attenzione alla parità di accesso e alla sostenibilità.

L'obiettivo dell'Azione comune sulla salute globale è **consolidare la leadership dell'Unione Europea in ambito sanitario globale**, istituendo meccanismi di rotazione che favoriscano un più stretto coordinamento e sinergie tra le istituzioni dell'UE e gli Stati membri. Questi meccanismi garantiranno il rispetto delle competenze di ciascun attore, facilitando al contempo il processo decisionale dell'UE attraverso i canali statutari già esistenti.

Regione Lombardia, unitamente all'Istituto Superiore di Sanità, Università Statale di Milano e Università Cattolica, è assegnataria del Work Package 7 "Strengthening external communication on EU contribution to Global Health", nell'ambito del quale

sono stati realizzati un'External Communication Plan e un questionario volto a diffondere il concetto di Sicurezza Globale nel circuito europeo.

OBJECTIVES AND CORE LINES OF ACTIONS

JA GHI aims at strengthening the visibility and impact of EU's strategy and contributions to global health.

JA GHI plans to put in place dynamic mechanisms and tools to achieve closer coordination and better knowledge exchange between EU institutions and Member States, as well as with civil society and non-EU stakeholders.

To that end, 4 core lines of actions have been defined.

1



Draw up and maintain a map of the strategies, priorities, key measures and initiatives, political developments and funding efforts of the EU and its Member States in the field of global health.

2



Improve the tools and processes for knowledge exchange between the EU and Member States in the many focal points dealing with global health (Brussels, Member State capitals, Geneva and New York, G7 and G20 health tracks, ...)

Piloted by Ministry of Health of the Czech Republic and Ministry of Health, Welfare and Sports of the Netherlands

Strengthen the Union's external communication on its strategy, achievements and impact, so that the objectives and efforts of the EU and its Member States in global health are properly understood and recognized.

Support and promote the "Team Europe" approach, being the hallmark of effective EU action in the field of health, in line with the "Global Gateway" strategy.

Set up a forum for suggestions from participating countries to anticipate and discuss cross-sectoral and complex issues related to global health, in order to support the EU's positioning on these subjects. The aim is to ensure that EU and Member State policies and positions are better aligned, coordinated, effective and influential

4 MAJOR EXPECTED OUTCOMES



A rolling mechanism that allows for continuous coordination and monitoring of national and European Global Health strategies' implementation (key measures, political developments, projects and financing efforts).



Digital solutions to improve knowledge exchange between national and European stakeholders.



Communication tools and activities to support the recognition of the 'Team Europe approach' as a trademark and extend the outreach of the EU Global Health Strategy impact.



An Open Suggestion Forum to better prepare and adapt EU positions.

The overall objective of the JA GHI is to enhance the EU's strategic approach and impact in global health processes and ensure the ability to speak with one strong and coherent voice, making its actions visible, understood and sound.



WORK PLAN STRUCTURE

This two-year project, started in October 2023, is structured in 8 work packages involving all participants as follows:

1. Coordination

Lead: France (Ministry of Labour, Health and Solidarities)

2. Communication and Dissemination

Lead: Poland (National Health Fund)

3. Evaluation and Impact Assessment

Leads: Germany (Robert Koch Institute) and Norway (Norwegian Directorate of Health)

4. Sustainability and Integration in the national policies

Lead: France (Ministry of Labour, Health and Solidarities)

5. Mapping of key measures and funding of the EU and its MS in global health and associated rolling coordination mechanism

Lead: Latvia (Pauls Stradins Clinical University Hospital)

6. Information and intelligence sharing among EU and MS in the focal points dealing with global health (Brussels, Member State capitals, Geneva and New York)

Leads: Czech Republic (Ministry of Health) and The Netherlands (Ministry of Health, Welfare and Sport)

7. Strengthen the EU external communication on its action on Global Health

Leads: Italy (Istituto Superiore di Sanita) and Greece (National and Kapodistrian University of Athens)

8. Suggestions Forum on improved EU coordination

Leads: Germany (Robert Koch Institute), Finland (Ministry of Social Affairs and Health) and Sweden (Public Health Agency of Sweden)

This **two-year project**, funded by the EU4Health programme with a contribution of 4.7 million euros, is coordinated by the French Ministry of Labour, Health and Solidarities.

Its activities begun on October 1st 2023 in close collaboration with the European Commission's Directorates - General and services, notably DG SANTE, DG INTPA and the European Commission's External Action Service.

The JA GHI consists of a consortium of **39 institutions representing 24 European countries, including Norway and Ukraine**, with a wide range of profiles (ministries of health and foreign affairs, national public health institutes and universities).
